#### **NOTIFICATION**

No. K. 12011/14/2010-REV/749-750, the 28th August., 2019. Whereas by the Government Notification No. K.12011/14/2010-REV, dated 12.09.2017 published vide Mizoram Gazette Vol -XLVI, Issue no. 505 dated 15.09.2017, it was notified under Section 11 (1) of The Mizoram (Land Acquisition, Rehabilitation and Resettlement) Act, 2016 (hereinafter referred to as the said "Act") that the land specified in the schedule indicated below was likely to be needed for the purpose namely – Acquisition of Land for construction of Project Site of EWS Housing at Hawngtial Ram, Aizawl District as per the direction of the Hon'ble Gauhati High Court Judgement & Order dt.16.05.2019 in WP(C) No. 128 of 2018 (Shri Lalthanmawia & anr -vs-State of Mizoram & 3Ors.).

- And whereas by the Government Notification No. K.12011/14/2010-REV/728, dt.27.04.2019 published in the official Gazette, it was notified under section 19(7) of the said Act that the 12 months period from the date of issue of the Preliminary Notification was extended till 14.09.2019 or till the instant Declaration under Section 19 is published in the Mizoram Gazette, whichever is earlier.
- 4. Now, therefore, the Government declares under Section 19 (1) of the said Act that the said land is required for the public purpose specified above and as per scheduled indicated below.
- 5. The Government now appoints the Deputy Commissioner, Aizawl District under Section 2 of the said Act to perform the functions of a Collector for all proceedings hereinafter to be taken in respect of the said land and directs him under Section 2 of the said Act to take order for the acquisition of the said land.
- 6. The Collector shall thereupon cause the land to be measured and make a plan of the same under Section 20 of the said Act if not already done as per Section 11 of the said Act, and dispose of all objections and claims after causing a public notice for not less than 30 (thirty) days to the persons interested stating the Government's intention of taking over the possession of the said land as per Section 21 of the said Act. Then, the Collector shall submit a Draft Award to the Government of Mizoram after fulfilling the provisions under Section 27 of the said Act.
- A plan of the same can be inspected at the Office of the Deputy Commissioner, Aizawl till the final award is made under Section 27 of the said Act.
