In pursuance of paragraph 11 of the Sixth Schedule to the Constitution of India, the following Rules passed by the Chakma Autonomous District Council which received approval of the Governor of Mizoram to take effect from 1st April, 2023 is hereby published for general information, namely :-

THE CHAKMA AUTONOMOUS DISTRICT COUNCIL (SALARIES AND ALLOWANCES OF CHIEF EXECUTIVE MEMBER AND EXECUTIVE MEMBERS) (SECOND AMENDMENT) RULES, 2023

In Exercise of the powers conferred by sub-rule (6) of Rule 22 of the CADC (Constitution, Conduct of Business etc.) Rules, 2002, read with sub-paragraph (6) & (7) of Paragraph 2 of the Sixth Schedule to the Constitution of India, the Chakma Autonomous District Council is pleased to further amend the CADC (Salaries & Allowances of CEM & EMs) Rules, 2003 (herein after referred to as the Principal Rules) and amended therein as follows:-

| Short title and Commencement | 1 | (1) These Rules may be called the Chakma Autonomous District Council (Salaries and Allowances of Chief Executive Member and Executive Member) (Second Amendment) Rules, 2023.
(2) It shall be deemed to have come into force on the 1 st day of April, 2023. |
| Amendment of Rule 2 | 2 | After sub-clause (j) of Rule 2 of the Principal Rules and its amended Rules 2012, the following definition shall be inserted namely:- |

“(k) Chairman, Town Committee” means a person who is appointed as Chairman, of Town Committee of the Chakma Autonomous District Council. He shall enjoy all benefits and entitlements as per the Executive Member of the Chakma Autonomous District Council”.

| Amendment of Rule 3 | 3 | <p>Rule 3 of the Principal Rules and its amended Rules 2012, shall be substituted with the following proviso namely:-</p> <p>“(3) There shall be paid be to the Chief Executive Member, Executive Members, Opposition Leader, Adviser to Chief Executive Member, Vice Chairman (Planning), and Chairman, Town Committee a fixed Salary of Rs 80,000/-(Rupees eighty thousand) only each per mensem”.</p> |
| Amendment of Rule 4 | 4 | <p>Rule 4 of the Principal Rules and its amended Rules, 2012 shall be substituted with the following proviso namely :-</p> <p>“4(1) There shall be paid to the Chief Executive Member a sumptuary allowances of Rs 35,000/- (Rupees thirty five thousand) only and Rs 30,000/- (Rupees thirty thousand) only to Executive Members, Opposition Leader, Adviser to Chief Executive Member, Vice-Chairman (Planning) and Chairman, Town Committee each per mensem”.</p> <p>(2) There shall be paid to the Chief Executive Member a family allowances of Rs 16,000/- (Rupees sixteen thousand) only and Rs 14,000/- (Rupees fourteen thousand) only to Executive Members, Opposition Leader, Adviser to Chief Executive Member, Vice-Chairman (Planning) and Chairman, Town Committee each per mensem”.</p> <p>(3) There shall be paid to the Chief Executive Member a entertainment allowances of Rs 16,000/- (Rupees sixteen thousand) only and Rs 8,000/- (Rupees eight thousand) only to Executive Members, Opposition Leader, Adviser to Chief Executive Member, Vice-Chairman (Planning) and Chairman, Town Committee each per mensem”.</p> |
| Amendment of Rule 5 | 5 | <p>Rule 5 of the Principal Rules and its amended Rules, 2012, shall be substituted with the following proviso namely;</p> <p>“5(1) The Chief Executive Member shall be entitled without any payment to the use and maintenance of a furnished residence throughout his term of office and for a period of fifteen days immediately thereafter; and so long as such residence is not provided he shall be entitled to a residence for which rental charge shall not be more than Rs 10,000/- (Rupees ten thousand) only per mensem and he shall be entitled to receive a sum of Rs. 1,00,000/- (Rupees one lakh) only for furnishing residence in the first year and Rs. 40,000/- (Rupees forty thousand) only annually for the subsequent years of his term of office for maintenance of residence.</p> <p>(2) The Executive Member, Opposition Leader, Adviser to Chief Executive Member, Vice-Chairman (Planning) and Chairman, Town Committee shall be entitled without any payment to the use and maintenance of a furnished residence throughout their term of office</p> |

and for a period of fifteen days immediately thereafter; and so long as such residence is not provided they shall be entitled to a residence for which rental charge shall not be more than Rs 8,000/- (Rupees eight thousand) only per mensem and they shall be entitled to receive a sum of Rs.1,00,000/- (Rupees one lakh) only each for furnishing residence in the first year and Rs. 40,000/- (Rupees forty thousand) only annually for the subsequent years of their term of office. for maintenance of residence.

“Provided that the rate of payment for electricity, calls of telephone, free water supply, local rates and taxes shall be fixed by the Chief Executive Member”.

Explanation

“Maintenance” in relation to residence includes,
 (i) Provision of free electricity and free water supply.
 (ii) Provision of free telephone calls and
 (iii) Provision of local rates and taxes”.
