## THE CHAKMA AUTONOMOUS DISTRICT COUNCIL (SALARIES AND ALLOWANCES OF CHAIRMAN AND DEPUTY CHAIRMAN) (SECOND AMENDMENT) RULES, 2023.

In Exercise of the powers conferred by Rule 19 of the CADC (Constitution, Conduct of Business etc.) Rules, 2002, read with sub-paragraph (6) & (7) of Paragraph 2 of the Sixth Schedule to the Constitution of India, the Chakma Autonomous District Council is pleased to further amend the CADC (Salaries & Allowances of Chairman and Deputy Chairman) Rules, 2003 (herein after referred to as the Principal Rules) and amended therein as follows:-

Short title and Commencement	1	<ol> <li>These Rules may be called the Chakma Autonomous District Council (Salaries and Allowances of Chairman and Deputy Chairman) (Second Amendment) Rules 2023.</li> <li>It shall be deemed to have come into force on the 1<sup>st</sup> day of April, 2023.</li> </ol>
Amendment of Rule 2	2	After Sub-clause (h) of Rule 2 of the Principal Rules and its amended Rules 2012, the following definition shall be inserted namely:- "(i) Deputy Chief Whip" means a person who is appointed as the Deputy Chief Whip of the Chakma Autonomous District Council. He shall enjoy all

		benefits and entitlements as per the Deputy Chairman of the Chakma Autonomous District Council.".
Amendment of Rule 3	3	Rule 3 of the Principle Rules and its amended Rules, 2012, shall be substituted with the following proviso namely:- "There shall be paid to the Chairman, Deputy Chairman and Deputy Chief Whip a fixed salary of Rs 80,000/- (Rupees eighty thousand) only each per Mensem.".
Amendment of Rule 4	4	<ul> <li>Rule 4 of the Principal Rules and its amended Rules 2012, shall be substituted with the following proviso namely:-</li> <li>"4(1) There shall be paid to the Chairman a sumptuary allowances of Rs 32,000/- (Rupees thirty-two thousand) only and Rs 30,000/- (Rupees thirty thousand) only in respect of Deputy Chairman and Deputy Chief Whip each per mensem.</li> <li>(2) There shall be paid to the Chairman a family allowances of Rs 15,000/- (Rupees fifteen thousand) only and Rs 14,000/- (Rupees fourteen thousand) only in respect of Deputy Chairman and Deputy Chief Whip each per mensem.</li> <li>(3) There shall be paid to the Chairman an entertainment allowances of Rs 13,000/- (Rupees thirteen thousand) only and Rs 8,000/- (Rupees eight thousand) only in respect of Deputy Chairman and Deputy Chief Whip each per mensem.</li> </ul>
Amendment of Rule 5	5	Rule 5 of the Principal Rules and its amended Rules shall be substituted with the following proviso namely; "5(1) The Chairman shall be entitled without any payment for the use and maintenance of a furnished residence throughout his term of office and for a period of 15 days immediately thereafter and so long as such residence is not provided he shall be entitled to a residence for which rental charges shall not be more than Rs 10,000/- (Rupees ten thousand) only per mensem and and he shall be entitled to receive a sum of Rs.1,00,000/- (Rupees one lakh) only for furnishing residence in the first year and Rs. 40,000/- (Rupees forty thousand) only annually for the subsequent years of his term of office for maintenance of residence.
		<ul> <li>The Deputy Chairman and the Deputy Chief Whip shall be entitled without any payment for the use and maintenance of a furnished residence throughout their term of office and for a period of 15 days immediately thereafter and so long as such residence is not provided they shall be entitled to a residence for which rental charges shall not be more than Rs 8,000/- (Rupees eight thousand) only per mensem and they shall be entitled to receive a sum of Rs.1,00,000/- (Rupees one lakh) only for furnishing residence in the first year and Rs. 40,000/- (Rupees forty thousand) only annually for the subsequent years of their term of office for maintenance of residence.</li> </ul>

Explanation		<ul> <li>Provided that rate of payment for electricity, calls of telephone, free water supply and local rates and taxes shall be fixed by the Chairman. However such fixation shall be in conformity with the Executive committee.</li> <li>"Maintenance" in relation to residence includes:-</li> <li>(i) Provision of free electricity and free water supply.</li> <li>(ii) Provision of free telephone calls and</li> <li>(iii) Provision of local rates and taxes".</li> </ul>
Amendment of Rule 6	6	In Rule 6 of the Principal Rules, after the words "Deputy Chairman" the words "Deputy Chief Whip" shall be inserted.
Amendment of Rule 7	7	In Rule 7 of the Principal Rules, after the words "Deputy Chairman" the words "Deputy Chief Whip" shall be inserted.
Amendment of Rule 8	8	In Rule 8 of the Principal Rules, after the words "Deputy Chairman" the words "Deputy Chief Whip" shall be inserted.
Amendment of Rule 10	9	In Rule 10 of the Principal Rules, after the words "Deputy Chairman" the words "Deputy Chief Whip" shall be inserted.
Amendment of Rule 11	10	In Rule 11 of the Principal Rules, after the words "Deputy Chairman" the words "Deputy Chief Whip" shall be inserted.
Amendment of Rule 12	11	Rule 12 of the Principal Rules and its amended Rules, 2012 shall be substituted with the following proviso, Namely; "12. The Chairman shall be entitled to receive the services of 3 (three) personal attendants to be appointed on MR (unskilled) according to own choice and the Deputy Chairman and the Deputy Chief Whip shall be entitled to the services of 2 (two) personal attendants each to be appointed on MR (unskilled) according to their own choice.
Amendment of Schedule	12	In Schedule (1), (2), (3), (4) and (5) of the Principal Rules and its amended Rules,2012, after the words "Deputy Chairman" the words "Deputy Chief Whip" shall be inserted.
Amendment of Schedule	13	<ul> <li>In Schedule of the Principal Rules and its amended Rules, 2012,</li> <li>(i) For the words and figures "Rs 500/-(Rupees five hundred) only" the words, figures and brackets, "Rs 1000/-(Rupees one thousand) only" within Mizoram shall be substituted.</li> <li>(ii) For the words and figures, "Rs 750/- (Rupee seven hundred fifty) only" the words figures and brackets, "Rs 2000 (Rupees two thousand) only outside Mizoram", shall be substituted.</li> </ul>
