THE CHAKMA AUTONOMOUS DISTRICT COUNCIL (SALARIES, ALLOWANCES AND PENSION OF MEMBERS) (THIRD AMENDMENT) RULES, 2023

In Exercise of the powers conferred by Rule 19 of the CADC (Constitution, Conduct of Business etc.) Rules, 2002, read with sub-paragraph (6) & (7) of Paragraph 2 of the Sixth Schedule to the Constitution of India, the Chakma Autonomous District Council is pleased to further amend the CADC (Salaries, Allowances and Pension of Members) Rules, 2003 (herein after referred to as the Principal Rules) and amended therein as follows:-

Amendment of Rule 4	3	In Rule 4 of the Principal Rules for the words and figures, "daily allowance of Rs 200/- (Rupees two hundred) each day" the words, figures and brackets, "daily allowances of Rs 1000/- (Rupees one thousand) only within Mizoram and Rs 2000/- (Rupees two thousand) only outside Mizoram shall be substituted.		
Amendment of Rule 5	4	Rule 5 of the Principal Rules and its amended Rules 2012 shall be substituted with the following proviso namely:- "5 A member shall be paid a constituency allowances of Rs 20,000/- (Rupees twenty thousand) only per mensem, family allowances of Rs 7000/-(Rupees seven thousand) only per mensem and contingency allowances of Rs 13,000/- (Rupees thirteen thousand) only per mensem."		
Amendment of Rule 6	5	In Rule 6 of the Principal Rules and its amended Rules, 2012 for the words and figures, "Rs 4000/- (Rupees four thousand) only per mensem" the words, figures and brackets, "Rs 8000/- (Rupees eight thousand) only per mensem", shall be substituted.		
Amendment of Rule 7	6	In Rule 7 of the Principal Rules and its amended Rules, 2012, for figures, brackets and words, "Rs. 30,000/- (Rupees thirty thousand)" the figures, brackets and words "Rs. 1,00,000/- (Rupees one lakh)" shall be substituted. And for the figures, brackets and words "Rs. 15,000/- (Rupees fifteen thousand)" the figures, brackets and words "Rs. 40,000/- (Rupees forty thousand) shall be substituted.		
Amendment of Rule 9	7	 In sub-rule (1) of Rule 9 of the Principal Rules and its amended Rules 2012, for the words and figures, "Rs 500/- (Rupees five hundred) only", the words, figures and brackets, "Rs 1000/- (Rupees one thousand) only", shall be substituted. In sub-rule (3) of Rule 9 of the Principal Rules and its amended Rules, 2012, the words and figures, "Rs 750/- (Rupees seven hundred fifty) only", the words, figures and brackets, "Rs 2000/- (Rupees two thousand) only", shall be substituted. 		
Amendment of Rule 12	8	 Sub-rule (2) of Rule 12 of the Principal Rules and its amended Rules 2012, shall be substituted with the following proviso namely:- "(2) (a) There shall be paid Rs 40,000/- (Rupees forty thousand) only per month to a member who had been elected/nominated once for 5 (five) years or for any period shorter than 5 (five) years. (b) If a member had been elected/nominated two terms or more, a sum of Rs 5000/- (Rupees five thousand) only per term shall be added to the initial pension of Rs 40,000/- (Rupees forty thousand) irrespective of the numbers of Terms a member is elected/nominated. (c) The Maximum amount of pension shall not exceed Rs 70,000/- (Rupees seventy thousand). (d) The Pension shall increased by 5 % (five percent) annually at simple interest rate. 		

		(2)	(e) There shall be paid a medical assistance of Rs 2000/- (Rupees two thousand) only per mensem to each former member.". After clause (c) of Sub-rule (3) of Rule 12 of the Principal Act and its amended Rules 2006, the following clause shall be inserted, namely :- "(d) Becomes a member of the Legislative Assembly or a Member of Parliament.".	
Amendment of Rule 13	9	In Rule 13 of the Principal Rules and its amended Rules, 2012, for the words, "five lakhs rupees ", the words, "ten lakhs rupees", shall be substituted.		
Amendment of Rule 14	10	(1)	In Sub-rule (1) of Rule 14 of the Principal Rules and its amended Rules, 2012, for the words, "family pension of ten thousand rupees per mensem", the words and figures, "family pension of 50% of the last pension received by the Ex-MDC or if a sitting MDC dies, 50% of the pension that would have been received by him and there shall be 5% increase of the family pension annually with maximum ceiling of Rs 50,000/- (fifty thousand rupees) only", shall be substituted.	
Insertion of new Sub-Rule 14(3)		(2)	In Rule 14 of the Principal Rules and its amended Rules, 2012, after Sub-rule (2) the following sub-rule shall be inserted as follows:- "14(3) The son or daughter of pensioner (member) is suffering from any disorder or disability of mind (including mentally retarded) or is physically crippled Or disabled so as to render him or her unable to earn a living the family pension shall be payable to such son or daughter after the death of the pensioner (member). Provided that the family pension shall also be eligible to the return divorced or judicially separated daughter of the deceased pensioner (member) till her death or remarriage, which ever is earlier. Provided further that son or daughter of a pensioner suffering from such incapacities mentioned in the above proviso the pension shall be payable for life.".	
Amendment of Rule 15	12	In section 15 of the Principal Rules, the words, "within India", shall be deleted.		
Amendment of Rule 17	13	(1) (2)	In sub-rule (1) (a) of Rule 17 of the Principal Rules, for the words, "three lakhs rupees", the words, "ten lakhs rupees", shall be substituted. In sub-rule (1) (b) of Rule 17 of the Principal Rules, for the words, "three lakhs rupees", the words, "ten lakhs rupees" shall be substituted.
