# **NOTIFICATION**

No.A.12018/20/2013-P&AR (GSW), the 19<sup>th</sup> February, 2019. In exercise of the powers conferred by the proviso to article 309 of the Constitution, the Governor of Mizoram is pleased to make the following rules further to amend the Mizoram Police Service Rules, 2008, namely:-

- 1. Short title and commencement
- (1) These rules may be called the Mizoram Police Service (Amendment) Rules, 2019
- (2) They shall come into force from the date of publication in the Official Gazette
- 2. Amendment of Rule 4

Entries in Rule 4 of the Mizoram Police Service Rules, 2008 (hereinafter referred to as the Principal Rule) shall be substituted as follows, namely:-

# "4. GRADATION OF THE SERVICE:

The service shall have the following grades –

- (i) Supertime Grade 'A'
- (ii) Supertime Grade 'B'
- (iii) Selection Grade
- (iv) Junior Administrative Grade
- (v) Senior Grade
- (vi) Junior Grade
- 3. Amendment of Rule 16

Entries in rule 16 of the Principal Rules shall be substituted as follows, namely;

#### "16. PAY ATTACHED TO THE DIFFERENT GRADES OF THE SERVICE:

The Level in the Pay Matrix attached to different grades of the service shall be as follows:

- a) Supertime Grade 'A': Level 14 in the Pay Matrix (^ 140200 194100)
- b) Supertime Grade 'B': Level 13A in the Pay Matrix (^ 131100– 216600)
- c) Selection Grade: Level 13 in the Pay Matrix (^ 123100- 215900)
- d) Junior Administrative Grade: Level 12 in the Pay Matrix (^ 78800–175200)
- e) Senior Grade: Level 11 in the Pay Matrix (^ 67700 150800)
- f) Junior Grade: Level 10 in the Pay Matrix (^ 56100– 124500)

4. Amendment of Rule 17

Entries in rule 17 of the Principal Rules shall be substituted as follows, namely;

#### "17. PROMOTION TO HIGHER GRADES OF THE SERVICE:

- 1) Promotion of members of the service to the Senior Grade, Junior Administrative Grade, Selection Grade, Supertime Grade 'B' and Supertime Grade 'A' shall be made in consultation with the Commission by selection method
  - 2. A member of the Service in the Junior Grade with a minimum of 5 (five) years of regular service in the Grade who is confirmed in Service and has passed Departmental Examination as prescribed under rule 12 shall be eligible for consideration for promotion to the Senior Grade
- 2) A member of the Service in the Senior Grade with a minimum of 5 (five) years of regular service in the grade failing which Officers in the Senior Grade with a minimum of 2 (two) years of regular service in the grade and have rendered a minimum of 10 (ten) years of regular service counted with effect from the date of entry in the Junior Grade of the service shall be eligible for consideration for promotion to the Junior Administrative Grade
- 3) A member of the Service in the Junior Administrative Grade with a minimum of 5 (five) years of regular service in the grade failing which Officers in the Junior Administrative Grade with a minimum of 2 (two) years of regular service in the grade and have rendered a minimum of 15 (fifteen) years of regular service counted with effect from the date of entry in the Junior Grade of the service shall be eligible for consideration for promotion to the Selection Grade
- 4) A member of the Service in the Selection Grade with a minimum of 5 (five) years of regular service in the Grade failing which Officers in the Selection Grade with a minimum of 2 (two) years of regular service in the grade and have rendered a minimum of 20 (twenty) years of regular service counted with effect from the date of entry in the Junior Grade of the service shall be eligible for consideration for promotion to the Supertime Grade 'B'
- 5) A member of the Service in the Supertime Grade 'B' with a minimum of 25 (twenty five) years of regular service counted with effect from the date of entry in the Junior Grade of the service shall be eligible for consideration for promotion to the Supertime Grade 'A'
- 5. Amendment of Schedule-I

The authorised permanent strength appearing at Schedule-I of the Principal rules shall be substituted as follows, namely:-
