The Committee shall be entitled to sitting allowance at the rate of Rupees One Thousand only per sitting or as may be decided by the Government from time to time.

The Committee member shall be entitled to TA/DA at the rate admissible to Joint Secretary to Government of Mizoram while performing duties assigned by the Committee.

Terms of reference :-

- 1. The Committee shall have the power to inspect and monitor any projects it deems necessary, leveraging the Integrated Programme Evaluation & Monitoring System dashboard for the purpose.
- 2. Quality Control Division under PWD will be at the disposal of the Committee as and when required.
- 3. The Committee shall be supported/assisted in its mandate by the Programme Implementation, Monitoring & Evaluation (PIME) Unit under the State Institute for Transformation, Planning & Programme Implementation Department.
- 4. The Committee shall take steps to ensure timely Completion of Projects.
- 5. The Committee may, if absolutely necessary, recommend revision of estimates of works / projects based on the site inspection report.
- 6. The, Committee shall take up other functions as may be assigned to it from time to time and submit recommendations to the Government.
