NOTIFICATION

No.B.13015/2/2019-LESDE/50, the 13th March, 2019. In the interest of public service and for effective implementation of Skill Strengthening for Industrial Value Enhancement (STRIVE) project, the Governor of Mizoram is pleased to constitute **State Steering Committee** (SSC) which shall be the apex body at the state level and shall be instrumental in reviewing the implementation of the STRIVE project. The State Steering Committee shall work in close coordination with the State Project Implementation Unit (SPIU) and shall recommend selection of evaluated Industrial Training Institute (ITI) and Industry Cluster (IC) to the National Program Implementation Unit (NPIU).

The composition of the State Steering Committee (SSC) shall be as follows:

The chairman of SSC may co-opt a representative from State Skill Development Mission (SSDM).

The State Steering Committee shall be responsible for:

- 1. Guiding and advising the work of the SPIUs including SAMCs and authorizing reports to the state government, the central government, the NSC, and the World Bank.
- 2. Assessing and recommending the Institute Strategic Plan (ISP) of Industrial Training Institute and proposals for Industry Apprenticeship Initiative (IAI) from Industry Clusters (ICs) for financing under the project.
- 3. Assisting selected ITIs in selection of Chairman of Institute Management Committee, if required.

- 4. Reviewing implementation progress periodically and providing directions on resolving the challenges faced in the operations including reform activities.
- 5. Recommending to National Steering Committee (NSC) proposal for use of incentive funds for State reforms.
- 6. Reviewing and approving the Annual Work Plan and Budget (AWPB) of the SPIU.
- 7. Overseeing operational activities of ITIs and ICs covered under the project in the state.
- 8. Reviewing and approving the training plans for the staff of SPIU and of institutions.
- 9. Meeting quarterly, or more frequently as required, to take stock of the project and facilitate project implementation.
- 10. Scrutinizing and recommending proposals to NSC for foreign training and study tours of SPI.
