Terms of reference for District Level Crop Varieties Recommendation Committee:

- 1. The Committee shall select and recommend suitable crop varieties of Agricultural and Horticultural crops for cultivation in their respective districts on basis of performances such as yield potential, resistance to diseases and pests, etc.
- 2. The Committee shall identify interested farmers groups/farmers and Farmers who can produce seeds of a particular varieties.
- 3. They will conduct Training and awareness among the farmers in order to promote seed production and become self sufficiency in seeds.
