No. G.16016/9/2023-F.Est/21, the 9th May, 2024: In exercise of powers conferred by sub-rule (1) of rule 4 of the Mizoram Lotteries (Regulation) Rules, 2019, read with rule 3 of the Lotteries (Regulation) Rules, 2010, the Government of Mizoram hereby frames the following Weekly lottery scheme, in the interest of public service and for generation, of additional revenues, through the Director, IF&SL:-

(l) Printing of tickets:

Printing of tickets will be done by the office of the Directorate of Institutional Finance & State Lottery. Distributor will convey the number and quantity of tickets required to be printed as per the market condition.

(m) The procedure for drawing the prize winning tickets or prize winners:

As mentioned above.

- The prizes are drawn using a Mechanical Draw Machine as per the guidelines stipulated in the Lotteries (Regulation) Rules, 2010, The Mizoram Lotteries (Regulation) Rules, 2019 and amendments made thereunder.

- (p) One ticket can win prizes of one rank only whichever is highest in terms of prize money. Holder of said ticket shall be entitled for all the prizes selected rank.
- (q) The Distributor and their Stockist / Sub-stockist / sellers, agents, retailers etc. are authorized to make payment of prizes up to the value of Rs.10,000/- to the prize winners and the Distributor, Sub-distributor, Area Distributors are authorized to reimburse the same on behalf of the Government of Mizoram.
- (r) Lotteries are conducted strictly in compliance with the Lotteries (Regulation) Act, 1998, the Lotteries (Regulation) Rules, 2010 and the Mizoram Lotteries (Regulation) Rules, 2019 and as amendments made thereunder.
- (s) All the tickets printed, shall have Logo and Imprint of the State with specimen signature, Date of Draw, time of Draw, Lottery Number with Series and a Barcode or QR Code as Security Measure.

Note: Details of unsold tickets, if any, shall be intimated by the Distributor before the draw time by means of electronic media or physically.

The revenues generated from the sale proceeds of the tickets shall be invested for the welfare of health care, education, publication, sanitation and other social sector services etc.
