NOTIFICATION

No. A.12018/39/2013-P&AR (GSW), the 22nd May, 2024: In exercise of the powers conferred under the proviso to article 309 read with article 234 of the Constitution, the Governor of Mizoram in consultation with the Mizoram Public Service Commission and the Gauhati High Court hereby makes the following rules further to amend the Mizoram Judicial Service Rules, 2006 (hereinafter referred to as the principal rules) namely:-

| 1. Short title and commencement .- | (1) These rules may be called the Mizoram Judicial Service (Amendment) Rules, 2024. |
| | (2) They shall come into force from the date of their publication in the Official Gazette. |
| 2. Amendment of rule 7 .- | In the principal rules, in sub-rule (c) of rule 7, the words and symbols “(Junior Division)” shall be inserted after the words “Civil Judge”. |
| 3. Amendment of rule 8 .- | In the principal rules, for rule 8, the following rules shall be substituted, namely :- |

“8. Pay and Allowances:

(1) The time scale of pay of the Mizoram Judicial Service shall be as under,-

(i) Grade I: District Judge Cadre:

(2) Allowances and other service benefit shall be as per entitlement notified by the Government in the Official Gazette from time to time. However, while granting ACP to Civil Judge (Jr. Division), the directions issued by the Hon'ble Supreme Court of India on 19.05.2023 In WPC 643/2013 "All India Judges Association Vs Union of India & Ors." shall be taken into consideration".

4. Amendment of rule 9 .-

In the principal rules, in column 2 of the table, against Sl. No. 3 of rule 9, the words and symbols "(Junior Division)" shall be inserted after the words "Civil Judge".

5. Amendment of Schedule A .-

In the principal rules, in the Schedule A, the following entries shall be substituted, namely:-

"The composition of the service and duty posts shall be as shown hereunder:

1. Grade-I District Judge. (35% of posts in Grade-I shall be in Selection Grade and 15% of Posts in Grade-I shall be in Super time Scale Grade w.e.f 01.01.2020).
2. Grade-II Civil Judge (Senior Division) Cadre.
3. Grade-III Civil Judge (Junior Division) Cadre.
