NOTIFICATION

No. G.27013/I/2017-LESDE/109, the 22nd May, 2024: In the interest of public service and for effective implementation of National Apprenticeship Promotion Scheme 2 (NAPS-2), the Governor of Mizoram is pleased to constitute State Level Implementation Review Committee (SIRC) within the State of Mizoram to promote and review the implementation of National Apprenticeship Promotion Scheme-2.

The composition of the State Level Implementation Review Committee (SIRC) will be as follows :-

1. Chairperson : Secretary, Labour Employment Skill Dev. & Entrepreneurship Department (LESDE)
2. Ex-Officio Member : Director, LESDE Department
Secretary
3. Members :
 1. Joint Director, LESDE Department
 2. Regional Director, (RDSDE), Guwahati
 3. Principal, Govt. ITI, Aizawl/Lunglei/Siaha
 4. State Engagement Officer, National Skill Development Corporation (NSDC)
 5. Director or his representative, Commerce and Industries Department.
 6. Director or his representative, Higher & Technical Education Department.
 7. Director or his representative, School Education Department.
 8. One Member (from Mizoram), North East Council, (CII).
 9. President or his representative, Mizoram Industry Owners Association.

Roles and Responsibilities of SIRC are :

- a) Overall implementation and monitoring of the Scheme, including compliance with the Scheme guidelines at the State-level.
- b) Reviewing State wide progress of Scheme, including the work plans and budget and taking corrective action.
- c) Conducting periodic review of the progress of the Scheme at the State level.
- d) Reviewing progress and achievement of the Key Performance Indicators (KPIs) to analyse the outcome of the Scheme at any point of time.
- e) Seeking periodic reports from the District Skill Committee

- f) Monitoring and reviewing the progress through DSCs and reporting the progress to State Skill Development & Entrepreneurship Committee (SSDEC) on apprenticeship engagement and to MSDE.
- g) Reviewing the State level awareness and mobilization efforts under the Scheme.
- h) Coordinate/support Scheme impact evaluation/assessment studies at the ground level.
- i) Compiling recommendations from state-level stakeholders for putting forward to SMRC and/or taking necessary actions on them as may be deemed fit.
- j) Any other matter as may be relevant for the effective implementation of the Scheme.
- k) The State Level Implementation Review Committee (SIRC) will convene every six months, although meetings may be convened by the Chairperson based on need, as on when required.
