#### **“THE MARA AUTONOMOUS DISTRICT COUNCIL (BOARD OF SCHOOL EDUCATION) (AMENDMENT) RULES, 2018”**

In exercise of the powers conferred under sub-paragraph (1) of paragraph 6 of the Sixth Schedule to the Constitution of India, the Mara Autonomous District Council, with the previous approval of the Governor of Mizoram, is pleased to amend the Mara Autonomous District Council (Board of School Education) Rules, 2010 (hereinafter referred to as the “Principal Rules”) as follows:-
