NOTIFICATION

No. B.12011/65/2019-C&I, the 13th June, 2024: In supersession of Notification issued vide No. B. 16025/9/2003-IND dated 25.06.2015, the Governor of Mizoram is pleased to revise various entitlements of the Chairman {Non-Official (Non MLA)} of the Public Sector Enterprises (Corporation/ Board) under the administrative control of Commerce & Industries Department, Govt. of Mizoram viz. ZIDCO Ltd., MIFCO Ltd., ZOHANDCO Ltd., MAMCO Ltd. and MKVIB as stated below until further orders:-.

Sl. No.	Category	Entitlement
(1)	(2)	(3)
1.	Honorarium	Rs. 40,000.00 (Rupees forty thousand) only per month
2.	Sitting Allowances	Rs. 1,000.00 (Rupees one thousand) only per sitting.
3.	Group 'D' (Casual Employee - Unskilled)	1 (one) no. co-terminus with the tenure of the concerned Chairman provided that the Chairman may terminate such engagement during his/her tenure if he/she deems it fit to do so. The rate of daily wages shall be as specified by the Labour, Employment, Skill Development & Entrepreneurship Department, Govt. of Mizoram from time to time.
4.	Driver {Semi- Skilled (Public Motor Transport employees)}-subject to non-availability of Driver under the concerned Corporation / Board.	1 (one) no. co-terminus with the tenure of the concerned Chairman provided that the Chairman may terminate such engagement during his/her tenure if he/she deems it fit to do so. The rate of daily wages shall be as specified by the Labour, Employment, Skill Development & Entrepreneurship Department, Govt. of Mizoram from time to time. Holder of valid Driving License as prescribed by Transport Department, Govt. of Mizoram from time to time is mandatory.
5.	Travelling Allowances/ Daily Allowances	At par with the entitlement of Administrative Head of Department (Secretary), Govt. of Mizoram.

6.	Home Furnishing	<p>A one-time grant of Rs.50,000.00 (Rupees fifty thousand) only for furnishing of the Residence of the Chairman taking 5 years as one tenure.</p> <p>Provided that if the same person is appointed again within a period of 5 years or on expiry of his/her 1st tenure, he/she shall not be eligible for fresh grant.</p> <p>The furnishing items shall remain the property of the Chairman when his/her tenure of office ends.</p>
7.	Telephone	At par with the entitlement of Administrative Head of Department (Secretary), Govt. of Mizoram. In case, however, the Chairman has his/her personal telephone at the Residence, the option of getting re-imbursement of Telephone bills subject to the prescribed limit shall be available to him.
8.	Accommodation at Mizoram House	At par with the entitlement of Administrative Head of Department (Secretary), Govt. of Mizoram.
9.	In case the post of Chairman is held by a sitting MLA, no honorarium or facilities specified for the Chairman (Non-MLA) would be provided by the Corporation/Board except Sitting Allowance and TA/DA as admissible to Chairman (Non-MLA) while performing activities connected with the Corporation/Board only.	

Consequent upon the above revision, the higher rate of Honorarium to the present incumbent of Chairman, viz. ZIDCO Ltd., MIFCO Ltd., ZOHANDCO Ltd., MAMCO Ltd. and MKVIB, shall be effective from the date of their joining their respective posts.
