#### **NOTIFICATION**

**No. C.31012/1/2010-VIG, the 27<sup>th</sup> August, 2024:** WHEREAS the three landmark Bills relating to the criminal justice system namely the Bharatiya Nyaya Sanhita, 2023, the Bharatiya Nagarik Suraksha Sanhita, 2023 and the Bharatiya Sakshya Adhinyam, 2023 were passed by the Parliament in December, 2023.

AND WHEREAS these three Criminal Laws is effective from 1<sup>st</sup> July, 2024.

AND THEREFORE, in the interest of the public service and to bring the Anti-Corruption Bureau, Manual, 2012 (herein after referred to as the principal manual) in consonance with the new Criminal Laws, the Governor of Mizoram is pleased to amend the ACB Manual, 2012 as follows:

**1. Amendment of paragraph 7.2.-**

In paragraph 7.2 of the principal manual, for the words "IPC" the words, figures and symbol "Bharatiya Nyaya Sanhita (BNS), 2023" shall be substituted.
