NOTIFICATION

No. K. 12011/62/2020-REV, the 1st February, 2023. WHEREAS by the Government Notification No.K.12011/62/2020-REV dated 19.04.2021 published in the official Gazette, it was notified under Section 11 (1) of the Mizoram (Land Acquisition, Rehabilitation & Resettlement) Act, 2016 that the land specified in the Schedule appended to the said Notification (herein after referred to as the "said land") was likely to be needed for public purpose, i.e construction of 20 towers as revised for 33 kv double Circuit Power Supply from Sihmui Sub-station to WTP Mualkhang, Tanhril to be constructed/developed by State Investment Program Management and Implementation Unit (SIPMIU)

And Whereas the period of Preliminary Notification issued on 19.04.2021 was extended upto 19th April, 2023 vide Notification No.K.12011/62/2000-REV dated 10.11.2022 due to unavoidable circumstances.

Now, therefore, the government declares under Section 19 (1) of the said Act that the said land is required for the public purpose specified above and as per scheduled indicated below.

The Government now appoints the Deputy Commissioner, Aizawl District under Section 2 of the said Act to perform the functions of a Collector for all proceedings hereinafter to be taken in respect of the said land and directs him under Section 2 of the said Act to take order for the acquisition of the said land.

The Collector shall thereupon cause the land to be measured and make a plan of the same under Section 20 of the said Act if not already done as per Section 11 of the said Act, and dispose of all objections and claims after causing a public notice for not less than 60 (sixty) days to the persons interested, stating the Government's intention of taking over the possession of the said land as per Section 21 of the SaidAct. Then, the collector shall submit a Draft Award to the Government of Mizoram after fulfilling the provisions under Section 27 of the said Act.

A plan of the same can be inspected at the Office of the Deputy Commissioner Aizawl till the final award is made under Section 27 of the said Act.
