THE TERMS OF REFERENCE AS BELOW :-

1. To promote Animal Welfare in general and advice the State Govt. in all matters concerning Animal Welfare.
2. The Board shall formulate appropriate regulations for the administration of its affairs subject to approval of the State Govt. for carrying out its function.
3. The Board shall meet at least twice in a year.
4. Non - Official members will be entitled of T.A. and D.A. as admissible to Group 'A' Officers, whenever they attend the meeting of the Board. The Director, AH & Veterinary Department will bear the expenditure from appropriate head of accounts.
5. The funds of the Board shall consist of grants made to it from time to time by the Government and of contributions, subscriptions, bequests, gifts and the like made to it by any local authority or by any other person.
6. The Government of Mizoram may on the recommendation of the Board remove a member from office at any time, the reasons must however be recorded in writing after giving him/her a reasonable opportunity of showing cause against the proposed removal and treated as casual vacancy for the purpose.
7. The terms of the Board shall be 3(three) years or as the Government may decide.
8. The office of the Board shall be located in the office of the Directorate of AH & Vety, Mizoram, Khatla, Aizawl or elsewhere as the Government may decide.
9. The Directorate of AH & Veterinary, Mizoram will provide all Secretariat assistance to the Board as and when required as long as provisions is not made for Board's own staff.
