NOTIFICATION

No.F. 15017/11/2019-GAD, the 6th September, 2019. In pursuance of the Minutes of the Meeting of the Coordination Committee on Traffic Management under the Chairmanship of Hon'ble Home Minister Pu Lalchamlia held on 25.4.2019, the Competent Authority is pleased to set up **Coordination Committee on Management of Aizawl City (CoMaCi)**. The main objective of CoMaCi is to create better coordination between different Government and Non-Governmental agencies such as PHE, PWD, SIPMIU, P&E, BSNL, etc. who execute works like laying of sewage or water pipeline, erecting or shifting of poles, construction or repairing of works, etc. within Aizawl Municipal Area, so that is minimal inconvenience for the public and to avoid wastage of Government resources and time.

The Coordination Committee on Management of Aizawl City (CoMaCi) is composed of the following members: -

The Terms of References of CoMaCi are as follows:-

- i) CoMaCi will meet before the end of each financial year to discuss the Annual Work Plan of the different agencies to be submitted to the Deputy Commissioner, Aizawl before the end of financial year by all work agencies who are executing any works within Aizawl Municipal Area. It will

decide on priority basis the order on which works are to be executed by the agencies if work is to be taken up in the same location.

- ii) It will meet at the end of each month to review the Annual Work Plan and decide on the work schedule for the next month.
- iii) At no instance shall any agency execute any work within Aizawl Municipal Area without the expressed approval of CoMaCi unless there are any unforeseen cases in which point no. iv below will be applicable.
- iv) It will appoint a Task Force to look into any emergency case where work has to be executed in which prior approval of CoMaCi is yet to be obtained.
- v) It will have complete authority over commencement of any work executed by Government or Non-Government Agencies within Aizawl Municipal Area. It will also have authority over stoppage or continuation of any on-going works which are executed by any agency within Aizawl Municipal Area. It will give a public notice of such works so that citizens are well informed in advance.
- vi) The Coordination Committee on Management of Aizawl City (CoMaCi) will commence from the date of Notification by the Government and will continue unless otherwise notified by the Government.
