**ANNEXURE-II**

**TERMS OF REFERENCE OF THE DISTRICT LEVEL TASK FORCE ON RUIHHLO DO**

**1. SUPPLY REDUCTION:**

1. Constitution of Village Level Task Force on Ruihhlo Do in their respective Jurisdiction.
2. Exchange of intelligence/information about trend of drugs trafficking.
3. Monitoring of illicit cultivation of Cannabis or Poppy crops in the district.
4. Identification of drug traffickers, peddlers and users.
5. Identification of likely places for manufacture of alcohol.
6. Performance of joint duties/raids on illicit trafficking/possession of drugs & liquor.
7. Conducting awareness programmes about the provisions of NDPS Act, Liquor Laws and harmful effect of drug & liquor. Awareness on importance of Prosecution witnesses.
8. Creation of 24x7 info. desk.
9. Other issues as deem fit.

**2. DEMAND REDUCTION:**

1. Train district and village level task force members and service providers on drug prevention and drug related harms and treatment services.
2. Generate awareness on drug prevention and drug related harms and treatment services through district level campaigns, workshops and trainings.
3. Facilitate setting up of drug treatment centres as required.
4. Provide for maintenance and upkeep of the drug treatment centres in the district.
5. Facilitate accreditation of drug treatment centres by setting up district level committees to fast-track the processes and help providing evidence based drug treatment services in remote locations.
6. Districts to facilitate the process of enlisting and updating evidence based quality drug treatment services and share it with the villages.
7. Awareness by Mizoram Journalist association.
8. Development of IEC materials.

**3. HARM REDUCTION:**

1. Coordinate with District AIDS Control Societies (DACs), Opioid Substitution Therapy (OST) Centres and HIV Programme Officers, IDU Targeted Interventions and HIV Link workers.
2. Generate Awareness on benefits of Harm Reduction Services, their uptake, and continued linkages with service providers.
3. Support formation of District level Drug Users forums and Self-Help Groups (SHG). e.g., Alcoholics Anonymous and Narcotics Anonymous and their active engagement in the various aspects of Harm Reduction Services.
4. Coordinate with the DACs, OST, HIVPOs and Link workers to facilitate registration of IDUs with OST, NSP and other Harm Reduction Services.
