Attention of all Administrative Departments/ Head of Departments is invited that the Election Commission of India (ECI) has launched Electors Verification Programme (EVP), 2019 wherein all voters of the country are required to verify their electoral details, make necessary corrections if needed, and upload at least I(one) document in proof of their identity. This verification, correction and uploading can be done by voters online through **nvsp.in** or through **Voter Helpline mobile app.**

As Voter Awareness Forums are constituted to make members aware of the various programmes of the Election Commission of India and take necessary actions so that all Voter Awareness Forums in offices under the Government of Mizoram are hereby instructed to conduct meeting/workshop wherein all members verify their details online and take necessary steps for correction of details if needed and upload documents as proof of their identity. **Procedures for verification through nvsp.in or through Voter Helpline mobile app is enclosed. The period of Electoral Verification Programme is 1.9.2019** to 15.10.2019.

Therefore, all Administrative Heads/Heads of Departments are requested to kindly submit compliance report to the Chief Electoral Officer, Mizoram and by District Election Officers in respect of offices under **their** jurisdiction in the following format.




