A RULES

Further to amend the Lai Autonomous Council (Group A, B, C & D Posts) Recruitment Rules, 2014
(*Herein after to as the Principal Rules*)

Be it enacted by the Lai Autonomous District Council in the Sixty Seventh years of the Republic of India as follows:

| | 2. | It shall come into force on the date of publication in the Official Gazette of Mizoram. |
| Amendment of schedule XX | 3. | a) In column 1 of Schedule XX of the Principal Rules, for the word ' Judicial Officer ', the word and figure ' 4. Judicial Officer (Entry Grade) ' shall be substituted. |

- b) In column 7 of Schedule XX of the Principal Rules, the words and figures '**Between 18-30 years of age. The upper age limit shall be relaxable upto 5 years for SC/ST**' shall be substituted by the words and figure '**Not more than 35 years of age, the upper age limit shall be relaxable upto 40 years of age for candidates belonging to Schedule Caste and Schedule Tribe**'.
- c) In column 8 of Schedule-XX of the Principal Rules, for the word '**local**' which appear between the words '**of**' and '**language**', the word '**Lai**' shall be substituted.
4. Above Serial No.4, as newly amended under Rule 3 of these Rules, Serial No. 1, 2 and 3 shall be inserted as follows.
