The Terms of reference (ToR) for MAMB shall be as under:

- (i) Identification and recommendation of crops to be notified for providing support price.
- (ii) Recommendation of the grade/standard/quality of notified crops for availing the support price.
- (iii) Promotion of Farmers' Societies/FPO/PACS/service providers, etc. to organise the collection, aggregation, value addition, post-harvest management of the notified crops and to establish long-term trade relations with clients or bulk buyers.
- (iv) To facilitate a business platform and promote trade relations between farmers' societies/PACS/FPOs service providers and prospective buyers and to empanel buyer for the notified crops.
- (v) Approval of contract agreement and Facilitation of Crop Insurance Companies in providing crop insurance.
- (vi) Promotion and facilitation of establishment of post-harvest infrastructure - collection & aggregation centres, processing & packaging units, store house/warehouse, etc.
- (vii) Organizing and developing a business platform for private/partnership firm/company from other states or foreign countries to invest/establish the processing and marketing of the notified crops with the local partner/firm/society.
- (viii) Facilitate convergence of the Centrally/State Sponsored/Sector Schemes and/or State Sponsor Scheme for promotion of agricultural production and market.
- (ix) To perform any other operations relating to agricultural marketing as may be assigned by the Government of India or State Government from time to time.
