- (p) The Distributor and their Stockist / Sub-stockist / sellers, agents, retailers etc. are authorized to make payment of prizes up to the value of Rs. 10,000/- to the prize winners and the Distributor, Sub-distributor, Area Distributors are authorized to reimburse the same on behalf of the Government of Mizoram.
- (q) Lotteries are conducted strictly in compliance with the Lotteries (Regulation) Act, 1998, the Lotteries (Regulation) Rules, 2010 and the Mizoram Lotteries (Regulation) Rules, 2019 and as amendments made thereunder,
- (r) All the tickets printed, shall have Logo and Imprint of the State with specimen signature, Date of Draw, time of Draw, Lottery Number with Series and a Barcode or QR Code as Security Measure.

**Note :** Details of unsold tickets, if any, shall be intimated by the Distributor before the draw time by means of electronic media or physically.

The revenues generated from the sale proceeds of the tickets shall be invested for the welfare of health care, education, publication, sanitation and other social sector services etc.
