- (r) All the tickets printed, shall have Logo and Imprint of the State with specimen signature, Date of Draw, time of Draw, Lottery Number with Series and a Barcode or QR Code as Security Measure.

Note: Details of unsold tickets, if any, shall be intimated by the Distributor before the draw time by means of electronic media or physically.

The revenues generated from the sale proceeds of the tickets shall be invested for the welfare of health care, education, publication, sanitation and other social sector services etc.
