**THE MIZORAM PRIVATE PLACEMENT AGENCIES (REGULATION)  
(AMENDMENT) ACT, 2025**

**AN  
ACT**

*to amend the Mizoram Private Placement Agencies (Regulation) Act, 2025.*

It is enacted by the Mizoram Legislative Assembly in the Seventy-Sixth Year of the Republic of India as follows:

**1. Short title, extent and commencement. –**

- (1) This Act may be called the Mizoram Private Placement Agencies (Regulation) (Amendment) Act, 2025.
- (2) It shall come into force on the date of its publication in the Official Gazette.

**2. Amendment of section 2.-**

In section 2 of the Mizoram Private Placement Agencies (Regulation) Act, 2025 (hereinafter referred to as the principal Act), in sub-section (1), in clause (q), for the word “training”, the words “orientation program” shall be substituted.

**3. Amendment of Chapter IV heading.-**

In the marginal heading of Chapter IV of the principal Act, for the words “its registered office in other States or Country”, the word “their registered office in other States or Countries” shall be substituted.

**4. Amendment of section 8 (C).-**

In section 8 (C) of the principal Act, in the last paragraph, after the words “beyond the boundaries”, the words “of India” shall be inserted.

**5. Amendment of section 11.-**

In section 11 of the principal Act, in sub-section (6), in clause (v), for the words, “Pre-Placement Orientation Certificate”, the words “Pre-Placement Orientation Program Certificate” shall be substituted.

**6. Amendment of section 19.-**

In section 19 of the principal Act, for the word “training”, the words “orientation program” shall be substituted.

**7. Amendment of section 20.-**

In section 20 of the principal Act:

- (a) In sub-section (2), in clause (a), for the words, bracket and figures, “the form and manner in which the license is to be issued under sub-section (1) of section 6”, the following shall be substituted, namely:- “the form and manner in which an application for grant of license shall be made under sub-section (1) of section 6”;
- (b) in sub-section (2), in clause (c), for the words, bracket and figures, “sub-section (5) of section 6”, The words, bracket and figures, “sub-section (7) of section 6” shall be substituted;
- (c) in sub-section (2), in clause (d), for the words, bracket and figures, “sub-section (6) of section 6”, the words, bracket and figures, “sub-section (8) of section 6” shall be substituted.
