## THE MARA AUTONOMOUS DISTRICT COUNCIL (SALARIES AND ALLOWANCES OF CHIEF EXECUTIVE MEMBER AND EXECUTIVE MEMBERS, ETC.) (THIRD AMENDMENT) RULES, 2023

In exercise of the powers conferred by sub–rule (6) of rule 22 of the Mara Autonomous District Council (Constitution, Conduct of Business, etc.) Rules, 2002, read with sub–paragraphs (6) and (7) of paragraph 2 of the Sixth Schedule to the Constitution of India, the Mara Autonomous District Council is pleased to further amend the Mara Autonomous District Council (Salaries and Allowances of Chief Executive Member and Executive Members) Rules, 2003 (hereinafter referred to as the "Principal Rules") and amended therein as follows:–

Short title and commencement.	1.	<ol> <li>These Rules may be called the Mara Autonomous District Council (Salaries and Allowances of Chief Executive Member and Executive Members, etc.) (Third Amendment) Rules, 2023.</li> <li>They shall be deemed to have come into force with effect from the 1<sup>st</sup> day of April, 2023.</li> </ol>	
Amendment of Rule 3.	2.	In rule 3 of the Principal Rules, for the word "forty", the word "eighty" shall be substituted.

Amendment of Rule 4.	3.	(1)	In cla (i) (ii)	use (a) of rule 4 of the Principal Rules– for the figures, brackets and words "Rs. 7,000/– (Rupees seven thousand)" the figures, brackets and words "Rs. 35,000/– (Rupees thirty–five thousand)" shall be substituted. for the figures, brackets and words "Rs. 6,000/– (Rupees six thousand)", the figures, brackets and words "Rs. 30,000/– (Rupees thirty thousand)" shall be substituted.
		(2)	In cla (i) (ii)	use (b) of rule 4 of the Principal Rules– for the figures, brackets and words "Rs. 6,000/– (Rupees six thousand)", the figures, brackets and words "Rs. 16,000/– (Rupees sixteen thousand)" shall be substituted. for the figures, brackets and words "Rs. 4,000/– (Rupees four thousand)", the figures, brackets and words "Rs. 14,000/– (Rupees fourteen thousand)" shall be substituted.

Amendment of Rule 5.	4.	For the first proviso to rule 5 of the Principal Rules, the following provision shall be substituted, namely:- "Provided that so long as such residence is not provided, the Chi Executive Member shall be entitled to a residence for which rental charge shall not be more than Rs. 10,000/- (Rupees ten thousand) only p mensem and the Executive Member, Opposition Leader, Adviser to Chi Executive Member, Deputy Chief Whip and Vice Chairman (Plannin shall be entitled to a residence for which rental charge shall not be more than Rs. 8,000/- (Rupees eight thousand) only per mensem. They shall be entitled to receive a sum of Rs. 1,00,0000/- (Rupees one lakh) on each for furnishing residence in the first year and Rs. 40,000/- (Rupee forty thousand) only annually for the subsequent years of their term office:"
