No. A. 26020/2/2023-DC&MA(M), the 9th February, 2024. In pursuance of paragraph 11 of the Sixth Schedule to the Constitution of India, the following Rules passed by the Mara Autonomous District Council which received approval of the Governor of Mizoram to take effect from 1st April, 2023 is hereby published for general information, namely :-

“THE MARA AUTONOMOUS DISTRICT COUNCIL
(SALARIES AND ALLOWANCES OF CHAIRMAN AND DEPUTY CHAIRMAN
(SECOND AMENDMENT) RULES, 2023.”

In exercise of the powers conferred by rule 19 of the Mara Autonomous District Council (Constitution, Conduct of Business, etc.) Rules, 2002, read with sub-paragraphs (6) and (7) of paragraph 2 of the Sixth Schedule to the Constitution of India, the Mara Autonomous District Council is pleased to further amend the Mara Autonomous District Council (Salaries and Allowances of Chairman and Deputy Chairman) Rules, 2003 (hereinafter referred to as the “Principal Rules”) and amended therein as follows:-

| | | (2) | They shall be deemed to have come into force with effect from the 1 st day of April, 2023. |

- Amendment of Rule 3.
2. In rule 3 of the Principal Rules, for the word "forty", the word "eighty" shall be substituted.
- Amendment of Rule 4.
3. For rule 4 of the Principal Rules, the following rule shall be substituted, namely:—
- "(4) (1) There shall be paid to the Chairman sumptuary allowances of Rs. 32,000/– (Rupees thirty-two thousand) only per mensem, family allowances of Rs. 15,000/– (Rupees fifteen thousand) only per mensem and entertainment allowances of Rs. 13,000/– (Rupees thirteen thousand) only per mensem.
- (2) There shall be paid to the Deputy Chairman sumptuary allowances of Rs. 30,000/– (Rupees thirty thousand) only per mensem, family allowances of Rs. 14,000/– (Rupees fourteen thousand) only per mensem and entertainment allowances of Rs. 8,000/– (Rupees eight thousand) only per mensem."
- Amendment of Rule 5.
4. In rule 5 of the Principal Rules—
- (i) for the figures, brackets and words "Rs. 5,000/– (Rupees five thousand) only per mensem", the figures, brackets and words "Rs. 10,000/– (Rupees ten thousand) only per mensem in respect of the Chairman and Rs. 8,000/– (Rupees eight thousand) only per mensem in respect of the Deputy Chairman".
- (ii) for the figures, brackets and words "Rs. 50,000/– (Rupees fifty thousand)", the figures, brackets and words "Rs. 1,00,000/– (Rupees one lakh)" shall be substituted.
- (iii) for the figures, brackets and words "Rs. 25,000/– (Rupees twenty-five thousand) only annually for the subsequent years", the figures, brackets and words "Rs. 40,000/– (Rupees forty thousand) only annually for the subsequent years of their term of office" shall be substituted.
- Amendment of Schedule.
5. In paragraph 1 of the Schedule to the Principal Rules—
- (i) for the figures, brackets and words "Rs. 500/– (Rupees five hundred)", the figures, brackets and words "Rs. 1,000/– (Rupees one thousand)" shall be substituted.
- (2) for the figures, brackets and words "Rs. 750/– (Rupees seven hundred and fifty)", the figures, brackets and words "Rs. 2,000/– (Rupees two thousand)" shall be substituted.
