#### **NOTIFICATION**

**No. K. 12011/54/2017-REV, the 4<sup>th</sup> Feb, 2019.** Whereas by the Government Notification No. K.12011/54/2017-REV, dt.31.10.2018 published in the official Gazette, it was notified under Section 11 (1) of The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (hereinafter referred to as the "said Act") that the land specified in the schedule appended to the said Notification was likely to be needed for the purpose namely – Construction of Zohmun to Palsang/Mauchar PMGSY Road, Aizawl District.

- 2. Now, therefore, the Government declares under Section 19 (1) of the said Act that the said land is required for the public purpose specified above and as per **Schedule** indicated below.
- 3. The Government now appoints the Deputy Commissioner, <u>Aizawl District</u> under Section 3 of the said Act to perform the functions of a Collector for all proceedings hereinafter to be taken in respect of the said land and directs him under Section 3 of the said Act to take order for the acquisition of the said land.
- 4. The Collector shall there upon make a plan as per survey and demarcation already done under Section 12 of the said Act and since no objections and claims from persons interested after causing a public notice stating the Government's intention of taking over the possession of the said land as per Section 21 of the said Act was received, the Collector shall submit a Draft Award to the Government of Mizoram after fulfilling the provisions under Section 27 of the said Act.
- 6. A plan of the same can be inspected at the Office of the Deputy Commissioner, Aizawl till the final award is made under Section 27 of the said Act.
