#### Terms of Reference of the Committee :

- (1) Review and monitor the implementation of the Protection of Women from Domestic Violence Act, 2005 in the State.
- (2) Study and identify problems and suggest action/requirement for protection of Women from Domestic Violence and also prevention of Human Trafficking in and from the State of Mizoram.
- (3) Identify problems and take remedial measures to overcome the various problems faced by different agencies involved in the implementation of various provisions of the Protection of Women from Domestic Violence Act, 2005.

- (4) To submit reports to the Government as well as recommendations for tackling the menace and remedial measures from time to time for which the Committee is expected to have meeting quarterly or at least twice in a year.
- (5) Any other works assigned to the Committee by the State Government or appropriate authority from time to time.
