## NOTIFICATION

**No.B.12022/I/2009-REV, the 30<sup>th</sup> August, 2013.** In exercise of powers conferred under Section 14 of the Mizoram (Land Revenue) Act, 2013 (Act No.5 of 2013) read with Rule 18(1) of the Mizoram (Land Revenue) Rules, 2013, the Governor of Mizoram is pleased to instruct all Settlement Officers/Assistant Settlement Officers of the Districts to properly demarcate the land(s) allotted under Office Memorandum issued by Revenue Department vide No.B.12022/I/2002-REV, dated 19th October, 2010 in respect of land assigned for New Land Use Policy (NLUP). In order to ascertain the genuineness of allotted land specially for implementation of NLUP, actual area along boundary description and location shall be meticulously recorded under **Provisional Land Lease with tenure 2 years** extendable for further period <u>subject to proper utilization/ development</u> of the land for the intended purpose. Concerned Revenue Officer(s) of the District shall take appropriate actions as above. Summary records of such exercise should also be endorsed to Deputy Commissioner of the District and Secretary, NLUP Implementing Board.

The content of this Notification shall be implemented forthwith.
