NOTIFICATION

No.B. 12012/16/2013-FST, the 10th December, 2013. Whereas, in exercise of the powers conferred by Sub-Sec I of Sec -18 of the Wildlife (Protection) Act, 1972, the Governor of Mizoram by reasons of the adequate ecological, faunal, floral, geomorphological, natural or zoological significance has declared its intention vide Notification No.B. 12012/19/01 - FST dt 29th July, 2004 to constitute the area specified in the Schedule to this Notification as "Wildlife Sanctuary" for the purpose of protecting, propagating or developing wildlife therein and its environment.

Whereas, as envisaged by Sec- 19 of the Wildlife (Protection) Act, 1972 and as directed by the Govt. of Mizoram in the said Notification, the District Collector, Kolasib District has carried out an enquiry into the existence, nature and extent of rights of person over the land comprised within the limits of proposed Pualreng Wildlife Sanctuary.

Now, therefore, in exercise of the powers conferred by Sec - 2A (1) of the Wildlife (Protection) Act, 1972, the Governor of Mizoram hereby declares the said area as specified in the Schedule below as "Pualreng Wildlife Sanctuary" with immediate effect and until further order.

SCHEDULE

- Name of the area :** Pualreng Wildlife Sanctuary
- Location :** It is started within Kolasib District, bordering with Aizawl District along R. Tuirial on the North, East and South; N.Hlimen & Thingthelh villages to the west and Bukpui village to the south-west under Thingdawl R.D. Block.
- Area :** 50Sq.Kms.
- Description of boundary :** The boundary of Pualreng Wildlife Sanctuary is as follows:
- North :** The boundary starts at the confluence of R. Tuirial with its tributary Tuiawn lui, it then follows Kolasib and Aizawl inter-district boundary along R. Tuirial upto Chengkawl lui.

- East** : The boundary runs towards south following R. Tuirial upstream all along the inter-district boundary of Kolasib and Aizawl Districts till it reaches the meeting point with Tuitla lui.
- South** : From the mouth of Tuitla lui the boundary thence runs toward west following Kolasib and Aizawl inter-district boundary upto the point where Tuiritai lui meets R. Tuirial.
- West** : The boundary follows Tuiritai lui in the north-westernly direction and then towards north till it meets Ramri lui. From Ramri lui it meets Tuiawn lui and follows downstream upto R. Tuirial.
