Terms of Reference:

- i. The Committee shall review the implementation of Central Sector Projects taken up in the State of Mizoram.
- ii. The Committee shall meet at least twice a year and more frequently if required.
- iii. The Committee shall address/resolve project related problems such as land acquisition, delays in getting environment/forest clearances, shifting of utilities etc. which cause time and cost overruns in the implementation of Central Sector Projects.
- iv. The Committee shall facilitate coordination between different State Government Departments/Agencies and with the concerned Central Ministries to smooth out codal formalities to expedite release of fund and execution of work.

Minutes of the meetings of the Committee shall be forwarded by Planning & Programme Implementation Department, Government of Mizoram to the Secretary, Ministry of Statistics & Programme Implementation, Government of India.
