The objects of the Council shall be to promote and protect within the State, the rights of Consumer in its State such as :-

- a) Rights to be protected against the Marketing of goods and services which are hazardous to life and property.
- b) Rights to be informed about the quality, quantity potency, purity, standard and price of foods or services so as to protect the Consumer against unfair trade practices.
- c) Rights to be assured, wherever possible, acces to a variety of goods and services at competitive prices.
- d) Rights to be-heard and to be assured that Consumer's interest will receive due consideration at appropriate forums.
- e) Rights to seek redressal against unfair trade practices or restrictive trade practices or unscrupulous exploitations of Consumers, and
- f) Rights to Consumer Education.

The terms of members of the Council shall be three years and they will be entitled to travelling and daily Allowances as laid down in Rule 5 of the Mizoram Consumer Protection 2010.

The District Consumer Protection Council shall meet as and when necessary, but not less than two meetings shall be held every year.
