TERMS OF REFERENCE :

- 1) The Advisory Boards shall hold at least two meetings in a year.
- 2) The Advisory Boards shall inspect the various institutional or non-institutional services in their respective jurisdictions; and the recommendations made by them, shall be acted upon by the Central Government and the State Government.
- 3) The District or State Advisory Board constituted in terms of sub-section (3) of section 62 of the Act shall also function as the inspection committee under section 35 of the Act.
- 4) The termination, resignation or other vacancy cause in an advisory board and appointment of new members therein shall be done in the same manner as in done in case of the competent authority.

VALIDITY : The validity of the Boards shall be 3 years
