Terms of Reference for State Mentoring Group on Community Action for Health (Community Monitoring) under NHM

1. To advise on developing and strengthening community partnership under NHM.
2. To identify organizations/institutions for implementing and providing technical support for Community Action for Health (CAH).
3. To issue necessary directives/guidelines to facilitate program implementation.
4. To periodically review the progress on implementation of CAH program and address systemic issues.
5. To facilitate greater inter-departmental coordination and convergence.
6. To facilitate creation of the spaces-platforms for community action at each level and their participation in government policy and programmes.
7. To examine proposals received for community/NGO participation under NHM.

The State Mentoring group may also be supported by technical group (can be termed Technical Advisory Group) which will provide technical guidance to the various aspects of implementation of the programme in the state. This may be constituted by the technical experts well known in their field in the state.

Terms of References for State Technical Members

1. To suggest strategies for CAH intervention at different levels.
2. To provide technical inputs for developing training modules for different stakeholders, IEC/BCC materials, report card, facility card etc.
3. To suggest new interventions in upcoming years PIP for improving the implementation of CAH program.
