## NOTIFICATION

No.A.17014/23/2011-HFW/Pt, the 16<sup>th</sup> July, 2014. In pursuance to the enactment of the Mizoram Clinical Establishments (Registration and Regulation) Rules, 2014, the Governor of Mizoram is pleased to constitute the District Registering Authority for the districts of Aizawl, Lunglei, Saiha, Champhai, Serchhip, Kolasib, Lawngtlai and Mamit in accordance with Section-10 of the Clinical Establishments (Registration and Regulation) Act, 2010, and Section-4 of the Mizoram Clinical Establishments (Registration and Regulation) Rules, 2014 for the purpose of registration of clinical establishments in each district comprising of the following members with immediate effect and until further orders.

Chairman : Deputy Commissioner Convener : Chief Medical Officer

Members : 1) District Medical Superintendent

- 2) Superintendent of Police
- 3) District Urban Development Officer, UD & PA

For the purpose of provisional registration of clinical establishments under Section - 14 of the Clinical Establishments (Registration & Regulation) Act 2010 and Section - 4 of the Mizoram Clinical Establishments (Registration & Regulation) Rules 2014, the Chief Medical Officer shall exercise the powers of the authority as per procedure that may be prescribed.

### FUNCTIONS OF THE DISTRICT REGISTERING AUTHORITY

- a) To grant, renew, suspend or cancel registration of any clinical establishments.
- b) To enforce compliance of the provisions and rules of the Clinical Establishments (Registration and Regulation) Act 2010.
- c) To investigate complaints of breach of the provisions of this Act or the rules made there under and take immediate action.
- d) To prepare and submit, on quarterly basis, report containing details of related to number and nature of provisional and permanent registration certificates issued; including those cancelled, suspended or rejected, to the State Council.
- e) To report to the State council, on a quarterly basis, on action taken against non-registered-clinical establishments operation in violation of the Act.
- f) Perform any other function as may be prescribed by the central government and/or the state government from time to time.

### POWERS OF THE DISTRICT AUTHORITY

The district authority shall, for the purpose of discharging its functions under this Act, have the same powers as are vested in a civil court under the Code of Civil Procedure, 1908, in respect of the following matters, namely:-

- a) Summoning and enforcing the attendance of any person and examining him on oath;
- b) Requiring the discovery and production of any document or other electronic records or other material objective producible as evidence;
- c) Receiving evidence on affidavits;
- d) Requisitioning of any public record;
- e) Issuing commission for the examination of witness or documents;
- f) Reviewing its decisions, directions and orders;
- g) Dismissing an application for default or deciding it exparte;
- h) Any other matter which may be prescribed.
