NOTIFICATION

No.B.12019/12/10-SWD, the 1st September, 2014. In exercise of the powers conferred under Sub-section 1 of Section 4 of the Juvenile Justice (Care & Protection of Children) Act, 2000(hereinafter called the Act) and on the recommendation of the Selection Committee, the Governor of Mizoram is pleased to notify the constitution of Juvenile Justice Board for the Districts of Aizawl, Mamit, Kolasib, Champhai, Serchhip, Lunglei, Lawngtlai and Saiha Districts (hereinafter called the Board) with the following members for exercising powers and discharging the duties conferred or imposed on such Board under the Act and the Mizoram Juvenile Justice (Care & Protection of Children) Rules, 2003 (hereinafter called the Rules) relating to the cases of Children in conflict with law:

Terms of reference:

- The Board will dispose the cases of the children in conflict with law as per the procedure laid down under the Act and the Rules amended from time to time. Notwithstanding, the Board may adopt a set Rules of procedure in conformity with the Act and the Rules for smooth functioning under intimation to the constituting Authority.
- 2. The Board will hold its sittings in the premises of an Observation Home while dealing with the cases of children in conflict with law. In Districts where there is no Observation Home, the Board will hold its sittings at a suitable premise as the board finds appropriate.
- The Board will have jurisdiction over their respective administrative districts. 3.
- 4. The Board will have a tenure of 3 years from the date of issue of this Notification.
