NOTIFICATION

No.D.26011/4/05-TRP, the 20th October, 2014. In continuation of this Department's Notification No.D.26011/4/05-TRP dt. 16.9.2014 and in pursuance to the joint meeting chaired by Chief Secretary on 31.7.2014 and in pursuance to the powers under clause 1 (iii) of proviso to Rule 108 of the Central Motor Vehicles Rule, 1989, read with the Notification No.S.O.52(E) dt. 11th January, 2002 issued by the Government of India, Ministry of Road Transport & Highways and in pursuance of the directions of the Hon'ble Supreme Court the Governor of Mizoram is pleased to specify that the following personages and officials shall be allowed to use following VIP lights of a bulb not more than seven watt power with/without flashers as described below :-

“Any vehicle carrying the dignitary formally designated by the Government of Mizoram as equivalent in rank, status and privileges to those dignitaries referred to above shall be entitled to use red, amber or blue light as per the corresponding/privileges.

The dignitaries who are entitled for use of red, amber or blue light may fit such light on their official vehicles and not on their private vehicle(s).

The light on the vehicles of all personages/officers/Agencies mentioned in the notification shall be covered with a black cover when they are not occupying the vehicle or are not on duty or when outside their jurisdiction.

All other unauthorized persons using such light in their vehicles shall be liable to be prosecuted as per provision of law.”

This Notification shall supersede all previous notification issued in this regard. This order will take immediate effect.
