ACT NO. 13 OF 2014 THE MIZORAM APPROPRIATION NO. 4 ACT, 2014

AN ACT

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State for the services for the Financial Year, 2014-2015.

It it enacted by the Legislative Assembly of Mizoram in the Sixty Fifth Year of the Republic of India as follows :-

Short Title

Issue of ^ 69510643000/- out of the Consolidated Fund of the State of Mizoram for the Financial Year, 2014-2015.

- 1. This Act may be called the Mizoram Appropriation Act, 2014
- 2. From and out of the Consolidated Fund of the State of Mizoram, there may be paid and applied the sums not exceeding those as specified in column (5) of the Schedule to this Act, amounting, in the aggregate, to the sum of Rupees six thousand nine hundred fifty one crore six lakh forty three thousand only for defraying the several charges which will come in course of payment for the Financial Year, 2014-2015 in respect of the services specified in column (2) of the Schedule.
- 3. The sums so authorised is inclusive of the sums already authorised under The Mizoram Appropriation (No.2) Act of 2014 (Vote on Account) and The Mizoram Appropriation (2nd Vote on Account) Act of 2014.

Appropriation

4. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Mizoram by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period.
