The Governing Body will be responsible for the following tasks -

- (i) Endorsement of Annual State Action Plan for ICDS Mission and a longer term road map;
- (ii) Review of implementation of Annual Action Plan and achievement of child-related outcomes;
- (iii) Suggest any mid-course correction that may be required in the State Mission strategy design frameworks;
- (iv) Review of inter-sectoral coordination;
- (v) Review of status of follow-up action on decisions of the State ICDS Mission;
- (vi) Appraise recommendations of the Executive Committee of the proposals and schemes and approve them based on die broad normative approved framework;
- (vii) Approval of proposals for institutional reforms; and
- (viii) Approve recommendations of the EPC on hiring of the experts and functionaries.
