Correspondence with Government of India and concerned State departments on the issue of Manual Scavenging.

No.B.13017/1/2013-GAD/16, the 13th January, 2015. Government of India has taken a very serious note of the issue of manual scavenging (removal of human faeces/night soil by human beings) and has initiated a number of measures to eradicate this problem. Even though Government of Mizoram maintains that this scourge does not exist in Mizoram, misinterpretation during the 2011 Census resulted in figures reflecting that manual scavengers exist here. However, there are related issues like, IMR, Sanitation, Cleanliness, etc.

For, this purpose, there is a need to coordinate the activities of different Departments like Rural Development, Health & Family Welfare, Social Welfare, Public Health Engineering, etc For the sole reason of correspondence with the Central Government and coordination of concerned Departments, the Government hereby designates General Administration Department (GAD) as the Nodal Department.
