Terms of reference

1. To adopt an approved standard form of writing Mizo Language.
2. To preserve and maintain/ as far as possible, commonly accepted meaning of words and phrases.
3. To initiate and encourage the study of the growth and development of Mizo Language from oral tradition to the present day.

4. To review and standardize Mizo Language Grammar.
5. To identify and adopt appropriate phonetic symbol and alphabets that can denote nuances of tones of Mizo words in formal writing.
6. To study and adopt systemic spelling of Mizo Language.

The Sub-Committee-I shall be responsible to study SI.No.1 to 3 of the Terms of Reference and submit its recommendations to the Committee. The Sub-committee-II shall be responsible to study SI.No.4 to 6 of the Terms of Reference and submit its recommendations to the Committee for consideration.

1. The Mizo Language Committee shall have the right to invite expert person(s) to help execute its objectives.
2. The Committee shall sit not less than three times in a calendar year.
3. The terms of office of the Mizo Language Committee shall be three years from the date of its notification.
4. The Committee shall reserve the right to reject or make additions or alternations to the recommendations of the Sub-Committee-I/Sub-Committee-II if considered necessary.
