Terms of Reference :

- i) The State ICDS Mission will be responsible for overseeing child development and nutrition system, consideration of policy matters related with child development and nutrition.
- ii) Review of progress in implementation of ICDS in Mission Mode by tracking child-related outcomes, using nutrition status of young children under three years as the lead outcome indicator;
- iii) Facilitate inter-sectoral coordination & convergence, advise on advocacy measures required to promote ICDS visibility in the State among others.
- iv) The State ICDS Mission would meet at least once in every six months and would have powers to co-opt members as and when needed.
