The State Executive Committee so constitute shall be the executive body of the Mizoram State Level Co-ordination Committee Constituted under Section 13 of the Act, and shall be responsible for carrying out the decisions of the said State Co-ordination Committee. The State Executive Committee shall also perform such other functions as may be delegated to it by the State Co-ordination Committee.
