NOTIFICATION

No.A.12018/26/2003-P&AR(GSW)/A, the 3rd August, 2015. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following Rules to amend the Mizoram Subordinate Stenographers Service Rules, 2004 (hereinafter referred to as the Principal Rules) notified vide No. A. 12018/26/2003-P&AR (GSW) dated 16.01.2004 and published in the Mizoram Gazette Extraordinary Issue No. 23 dated 22.01.2004, namely:-

- 1. Short title and commencement
- (1) These Rules may be called the Mizoram Subordinate Stenographers Service (Amendment) Rules, 2015.
- (2) These Rules shall come into force from the date of publication in the Official Gazette.
- 2 Amendment of Rule 10
- (1) Sub-rule (I)(b) of Rule 10 of the Principal Rules, shall be substituted as follows, namely;
 - "50% of the posts in this grade shall be filled up by promotion from amongst the member of Stenographer Grade-III with not less than 5 (five) years of regular service in the grade on the basis of seniority-cum-merit and are duly recommended by the Departmental Promotion Committee"
- (2) Sub-rule (I)(c) and sub-rule (I)(d) of Rule 10 of the Principal Rules shall be deleted
- (3) Sub-rule (2)(b) of Rule 10 of the Principal Rules shall be substituted as follows, namely;
 - "In order to be eligible to compete in direct recruitment examination for appointment to Grade-III, a candidate must be:-
 - (i) A citizen of India
 - (ii) Graduate from a recognized University
 - (iii) Holder of Diploma Certificate in English Stenography
 - (iv) Between 18 years to 35 years. Upper age limit is relaxable by 5 (five) years in case of SC/ST candidates

Ex-383/2015 - 2 -

- (v) Having working knowledge of Mizo language at least Middle School standard
- (vi) Computer knowledge of at least 6 (six) months in Computer Application consisting of (1) Microsoft Word (2) Microsoft Excel (3) Page Maker from Institutions recognized by the Mizoram State Council of Technical Education (MSCTE), Higher & Technical Education Department, Government of Mizoram"
- 3. Amendment of Rule 13
- (1) Entries under Rule 13 of the Principal Rules shall be substituted, as follows, namely;
 - "The Departmental Promotion Committee for direct recruitment and promotion to various grades of the Service shall be as constituted by the Government from time to time"
- 4. Amendment of Rule 14
- (1) Entries under Rule 14 of the Principal Rules shall be substituted as follows, namely;
 - "The Pay Band and Grade Pay attached to the grades of the Service shall be as follows:
 - I) Grade-II PB-2: ^ 9,300-34,800 + ^ 4400 GP
 - 2) Grade-III PB-2: ^ 9,300-34,800 + ^ 4200 GP"
