That for the purpose of evedencing such my determination I declare that I shall at all times hereafter in all records, deeds and writing and in all proceedings, dealings and transactions of private as well as public and upon all occasions whatsoever use and sign the name of **Tiruvaipati Venkata Jagannadha Rao** as my name in place of and in substitution for my former name of **Tiruvaipeta Venkata Jagannadha Rao**
- 4. That the purpose of this evidence is to declare that my true and corect name is **Tiruvaipati Venkata Jagannadha Rao** and not **Tiruvaipeta Venkata Jagannadha Rao**.
- 5. That I expressly authorize and request all persons at all times hereafter to designate and address me such assumed name of **Tiruvaipati Venkata Jagannadha Rao** accordingly.
