NOTIFICATION

No.B.12019/9/2015-EDN (VSE), the 27th August, 2015. The Department of School Education is the implementing agency of the ongoing National Programme for universalisation of Secondary Education viz Sarva Shiksha Abhiyan (SSA) and Rastriya Madhyamik Shiksha Abhiyan (RMSA) in the state of Mizoram. For effective and efficient implementation of Sarva Shiksha Abhiyan (SSA) and Rastriya Madhyamik Shiksha Abhiyan (RMSA), the Mizoram Education Mission Society has been constituted under School Education Department.

Of late The Centrally Sponsored Scheme of "Vocationalisation of Higher Secondary Education" has been revised by the Government of India, Ministry of Human Resource Development in the name of "Vocationalisation of Secondary and Higher Education". The Revised Scheme had also been subsumed under the Rastriya Madhyamik Shiksha Abhiyan (RMSA) Scheme with effect from 1st April, 2013.

For the implementation of the Revised Vocational Education Scheme in the State of Mizoram, the Mizoram Board of School Education approved the under mentioned Vocational Courses at the Secondary level as an additional subject in conformity with the National Vocational Education Qualification Framework (NVEQF) prepared by Pandit Sunderlal Sharma Central Institute of Vocational Education (PSSCVIVE), Bhopal.

1. Automobile Service Technician
2. Information Technology/Information Technology Enabled Services (IT/ITES)
3. Organised Retailing
4. Private Security
5. Healthcare

As required by the Revised Scheme, proposal as per revised norms of the Scheme was submitted as part of the consolidated Annual Work Plan and Budget under RMSA for consideration by the Project Approval Board 2015-16. Accordingly, the Project Approval Board has now approved the proposal of the Mission Director, Mizoram Education Mission Society for the introduction of the Revised Vocational Education Scheme in 10 (ten) Schools from Class IX in respect of two vocational trade viz. Information Technology and Information Technology enabled Services (IT & ITes from Desk Operator) and Healthcare (General Duty Assistant) with financial implication of Rs.328.35 lakhs.

In pursuance of the concurrence of Project Approval Board, the Governor of Mizoram is therefore, pleased to notify the implementation of the Revised Vocational Education Scheme in ten (10) Government High School and the cost for different components is as indicated below.
