The terms of reference for District Level Managing Board, Fish Farmers Development Agency for all Units Aizawl, Lunglei, Saiha, Lawngtlai, Kolasib and Mamit are as under -

- 1. Duration of terms of :- 2 years from the date of formation the Board
- 2. Duties and responsibilities :-
- Recommending programmes as per guidelines of Fish Farmers Development Agency pertaining to the District for approval by the State Level Managing Board for submission of proposal to Govt. of India.
- Recommending beneficiaries for final selection by the State Level Managing Board in line with programmes agreed and fund released by the State Level Managing Board pertaining to the Dist.
- (iii) District Level Monitoring and evalution of the programmes and approval of the reports for submission to the State Level Managing Board.
- (iv) The District Level Managing Board should have at least 3(three) sittings in every financial year.
  - (a) For recommending activities to be taken up.
  - (b) For recommending beneficiaries for final selection.

(c) For veview of minitoring and evaluation report for submission to the State Level Managing Board.
