NOTIFICATION

No.K.15012/II/2010-REV, the 14th September, 2015. Whereas the land specified below with a total of 3.85 Ha. has to be transferred to the Environment & Forest Department, Government of Mizoram for the purpose of compensatory afforestation under the Forest (Conservation) Act, 1980 in lieu of reserved forest diverted due to the construction of Mizoram State Road Project (MSRP)-II (Grade-I) for Chhumkhum-Chawngte Road.

Now, therefore, the Government of Mizoram is pleased to mutate the land specified below to Environment & Forest Department, Government of Mizoram with immediate effect to be included in the Reserved Forest as defined under sub-section (35) of section 2 of the Mizoram (Land Revenue) Act, 2013 read with sub-section (1) of section 12 of the said Act.

Description of Land:

1. Location : Sasaw Tlang, Sawleng.
2. RD Block : Darlawn
3. District : Aizawl
4. Area in Ha. : 3.85

Boundary Description:

- Starting Point The boundary line start from North West of the land along the foot-path with BP No.1 near the stream.
- BP No.1-2 From BP No.1 the boundary line runs in the direction of 105° 41' 39" along the foot-path with BP No.2 at a distance of 58.54 m(h/d)
- BP No.2-3 From BP No.2 the boundary line runs in the direction of 77° 20' 12" along the foot-path with BP No.3 at a distance of 98.09 m(h/d).
- BP No.3-4 From BP No.3 the boundary line runs in the direction of 93° 12' 31" along the foot-path with BP No.4 at a distance of 146.54m (h/d).
- BP No.4-5 From BP No.4 the boundary line runs in the direction of 165° 24' 12" along the boundary line of the land bank with BP No.5 at a distance of 104.99 m (h/d).
- BP No.5-6 From BP No.5 the boundary line runs in the direction of 256° 01' 08" along the waste land with BP No.6 at a distance of 56.83 M (h/d).

- BP No.6-7 From BP No.6 the boundary line runs in the direction of 267° 48' 41" along the waste land with BP No.7 at a distance of 70.85 m (h/d).
- BP No.7-8 From BP No.7 the boundary line runs in the direction of 295° 49' 47" along the waste land with BP No.8 at a distance of 70.61 m (h/d).
- BP No.8-1 From BP No.8 the boundary line runs in the direction of 12° 59' 05" along the stream with BP No.1 at a distance of 70.61 m(h/d).

Therefore the total area of the demarcated land is 3.85 Ha. This land is demarcated out of a total land bank area of 1648.94 Ha already transferred and mutated vide Memo No.K.15011/3/92-REV, dt.4.2.2010 in respect of Tipaimukh Multi-Hydro Electric Project.

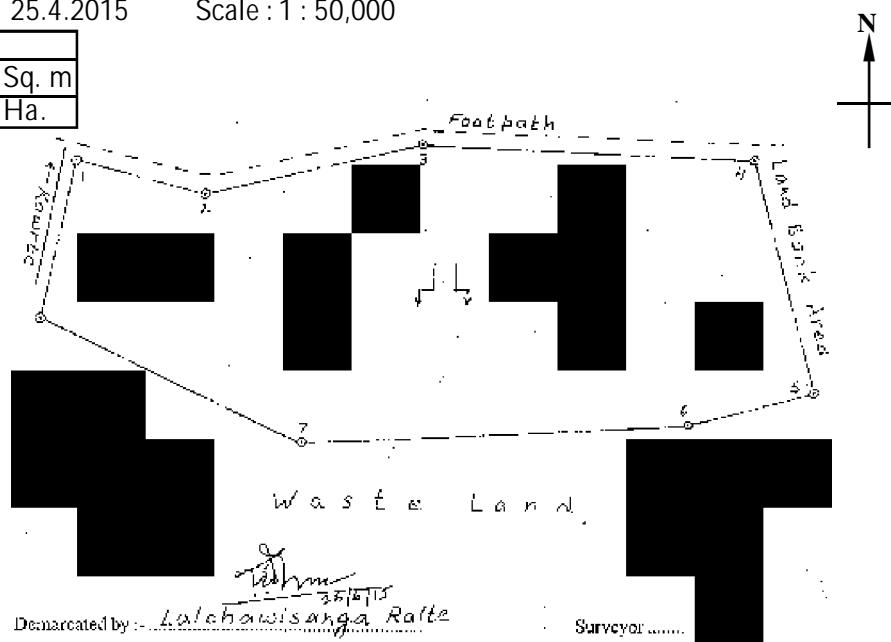
