NOTIFICATION

No.A. 45011/1/2014-HM(CD), the 20th April, 2016. The Govt. of India, Ministry of Home Affairs vide its order No. I. 45011/22/2012-AD(CD) dated 6th June, 2014 has launched a ***"Plan Scheme of Mainstreaming Civil Defence in Disaster Risk Reduction"***. The Scheme is to be implemented in all the 8 (eight) districts of the State, all having been declared as 'Most Vulnerable Districts' (MVDs) under the Scheme. For the implementation of the Scheme and in pursuance of the decision of the Meeting of the Council of Ministers held on 7.4.2016, the Governor of Mizoram is pleased to order **Raising of Civil Defence Corp** at the State Headquarters and all the 8(eight) districts of Mizoram in accordance with Sec 4(1) of the Civil Defence Act, 1968.

2. Civil Defence and Home Guards, being complementary organizations, the Civil Defence Organisation so created shall be combined with the existing Mizoram Home Guards set-up and as per the approval of General Administration Department vide I.D. No. GAD : 195/2015 dt. 30.12.2015, the Governor of Mizoram is pleased to rename ***'Mizoram Home Guards Department'*** as the ***'Mizoram Home Guards and Civil Defence Department'***.

3. Further, the existing designation of the following posts under the Mizoram Home Guards Department are hereby re-designated as follows, in accordance with Sec 4(2), Civil Defence Act, 1968, without any change in the existing pay scales and shall accordingly discharge the functions as assigned to them under the Act, Rules and Regulations in force pertaining to Civil Defence :

1.	Director General, Mizoram Home Guards	Director General of Home Guards & Civil Defence
2.	Commandant General, Mizoram Home Guards	Commandant General, Mizoram Home Guards-cum- Addl. Director, Civil Defence
3.	Deputy Commandant General, Mizoram Home Guard	Deputy Commandant General, Mizoram Home Guards-cum-Jt. Director, Civil Defence

Para 3. issues with the approval of DP&AR (ARW) vide I.D. No. ARW/HM (HG)/2015-2016/B-156 dt. 14.9.2015 and concurrence of Finance Department (Establishment) vide I.D. No. FIN (E) 503/2015 dt. 29.9.2015.

4. In addition, the Deputy Commissioners (DCs) and SDO (S) of each District are hereby designated as the Controller and Deputy Controller, Civil Defence respectively pertaining to their Districts based on the provision of Sec 4(1) and 17(b) of the Civil Defence Act, 1968. The services of Officers and Staff of Deputy Commissioners' establishment in all the eight districts of Mizoram shall be utilized in connection with setting up and functioning of Civil Defence Corps in the eight districts.
