WHEREAS, in pursuance of the Commission's Notification issued under Memo of even No, dt. 1.4.2016, Elections have been held for the purpose of constituting 10 (ten) Village Councils under Chakma Autonomous District Council on 28th April, 2016 and;

WHEREAS, the results of the election to the said Village Councils has been declared by the Returning Officers concerned on 29th April, 2016 and in exercise of the powers conferred under sub-section (6) of Section 6 of the Chakma Autonomous District Council (Village Councils) (Amendment) Act, 2011 read with sub-section (7) of Section 3 of the Chakma Autonomous District Council (Village Councils) (Amendment) Act, 2014, the State Election Commission hereby orders that the first meeting of all newly constituted Village Councils presided over by the Returning Officers concerned, shall be held on or before **10th May, 2016**. Further, the report regarding formation of Executive Body shall be submitted to the Deputy Commissioner/District Election Officer, Lawngtlai and Local Administration Officer, CADC on or before **12th May, 2016**;
